NOTICE OF NOMINATION FOR OFFICE
Municipal Elections Act, 1996, as amended (s.32)

NOTICE is hereby given to the Municipal Electors of the Municipality of South Bruce That nomination for the offices of:

- **MAYOR**
- **TWO (2) COUNCILLORS** for the Mildmay-Carrick Ward
- **TWO (2) COUNCILLORS** for the Teeswater-Culross Ward
- **TWO (2) COUNCILLORS AT LARGE**

may be made by completing and filing in the office of the Clerk of the Municipality of South Bruce nominations on the prescribed form and accompanied by the prescribed nomination filing fee of \$200.00 for the Head of Council and \$100 for all other offices. The filing fee is payable by cash, certified cheque, money order or electronic Payment if specified by the Clerk.

A nomination form must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 1, 2018 and July 26, 2018 and between 9am and 2pm on July 27, 2018 (Nomination Day).

All nominations must be certified by the Clerk or designate before such person becomes a certified candidate for the office to which she or he is nominated.

NB: Until such time as a nomination has been filed and certified, no person may solicit, accept campaign contributions or incur expenses for election purposes.

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 1, 2018, between the hours of 9 am and 2 pm and such additional nominations, if required, may be filed in the Office of the Clerk.
