

**CORPORATION OF THE MUNICIPALITY OF SOUTH BRUCE  
BY LAW 2008-73**

**BEING A BY-LAW TO AMEND BY-LAW 2008 - 02 TO GOVERN THE PROCEEDINGS OF  
COUNCIL AND ITS COMMITTEES AND BOARDS, THE CONDUCT OF ITS MEMBERS  
AND THE CALLING OF MEETINGS.**

**WHEREAS** the Municipal Act 2001, as amended, section 238, sub-section (2), provides that every municipality and local board shall pass a procedure by-law for governing the calling, place and proceedings of meetings; and

**WHEREAS** the Council of the Municipality of South Bruce deems it necessary to pass a by-law to amend By-law 2008-02;

**NOW THEREFORE** the Council of the Corporation of the Municipality of South Bruce enacts as follows:

**RE: Section A5, Regular Meetings, Subsection 1-3**

That Section A5.1 be amended as by deleting

*A5.1 Council Meetings shall be held on the first, second and third Tuesdays of the month, in the Council Chambers*

*A5.2 Regular Meetings of Council shall commence at 6:00 p.m. for a duration of no more than three and one half hours (9:30 p.m.) Unless otherwise determined by a resolution of Council passed by a majority of the whole number of the members, the Council shall adjourn at 9:30 p.m. in the regular evening session. Any unfinished business will be dealt with first on the next agenda.*

*A5.3 The first meeting of the month will include Staff Reports from the Roads, Parks Landfill Site, Water, Wastewater Departments.  
The second meeting of the month will include Staff Reports from the Municipal Inspector, the Recreation Program and Facilities Supervisor. and the Report of the Administrator which may include Planning and Economic Development;  
The third meeting of the month will include the Reports of the Treasurer, and the Clerk  
Any Reports or Reports of a General Nature may be included on the Agenda of any Meeting following the requirements of Section A7 of by Law 2008-02*

And substituting the following thereto:

*A5.1 Council Meetings shall be held on the second and fourth Tuesdays of the month, in the Council Chambers.*

*A5.2 Regular Meetings of Council shall commence at 6:00 p.m. for a duration of no more than four hours (10:00 p.m.) Unless otherwise determined by a resolution of Council passed by a majority of the whole number of the members, the Council shall adjourn at 10:00 p.m. in the regular evening session. Any unfinished business will be dealt with first on the next agenda.*

*A5.3 The first meeting of the month will include Staff Reports from the Roads, Parks Landfill Site, Water, Wastewater Departments, Municipal Inspector, and the Report of the Administrator which may include Planning and Economic Development;  
The second meeting of the month will include the Reports of the Recreation Program and Facilities Supervisor, Treasurer, and the Clerk.  
Any Reports or Reports of a General Nature may be included on the Agenda of any Meeting following the requirements of Section A7 of by Law 2008-02*

**NOW THEREFORE** the Council for The Corporation of the Municipality of South Bruce **ENACTS** as follows:

1. That By-law No. 2008-22, is hereby repealed.
2. This By-law shall come into full force and effect on January 1, 2009
