



## MUNICIPALITY OF SOUTH BRUCE PREAUTHORIZED TAX PAYMENT PLAN

---

### Benefits of Pre-authorized Payment Plan

- Payments are automatically deducted from your bank account;
- No cheques to write,
- No postage,
- No due dates to remember,
- No penalty charges.

### Two plans to choose from:

1. Withdrawn monthly (15<sup>th</sup> of each month)
2. Withdrawn on due date from your tax bill.

### Monthly Payment Plan

11 regular monthly payments will be withdrawn on the 15<sup>th</sup> of each month. Payments begin January 15<sup>th</sup> through to November 15<sup>th</sup>. Any balance owing will be taken on December 15<sup>th</sup>. The first 11 payments are calculated based on the previous year's taxes plus 3%, then divided by 11. The 12<sup>th</sup> payment (December) is the current year's taxes less any payments over the past 11 months to bring your property tax account to current status.

### Who is eligible?

Any ratepayer in the Municipality of South Bruce whose accounts are paid in full may join.

### How it works

- Taxes are estimated for the year and divided into 11 monthly payments.
- Adjustments to monthly tax payments will be made in November or December.
- Returned payments will be subject to penalty and interest charges as well as the Administration Fee.

### How to apply

- Complete the application form below
- Attach a cheque marked "VOID" or Banking PAD Form with your bank account
- Return the application and **Voided Cheque Or Bank PAD Form** to:

### Termination of the Plan

If you wish to withdraw from the plan, please notify the Tax Department in writing 30 days prior to your next withdrawal date.

The municipality of South Bruce may cancel the privilege of continuing the plan if two payments fail to be honoured. Any unpaid balances due to a payment not being honoured shall be subject to penalties if overdue.

**Please notify the Tax Department in writing immediately if you move or change your bank account.**
